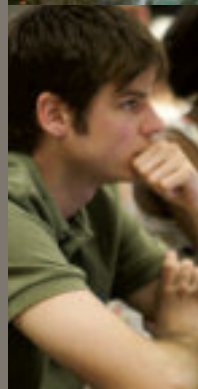

### SMALL CLASS SETTINGS
