Thank you and congratulations to the Georgetown Law alumni who volunteered for the 11th annual Law Firm Challenge this year. The Challenge helps alumni stay abreast of Law Center news, while having a positive impact on the programs, resources and student experience at the school today. And the law firms that join the challenge also forge strong connections with Georgetown Law and its students.

This year's Law Firm Challenge involved 1,938 alumni and 44 prominent law firms and companies. Fifty-two percent of the alumni at these firms contributed a record total of more than \$980,000 to the Law Center.
