

CLINIC APPLICATION & ENROLLMENT STATISTICS

The chart on the next three pages contains application and enrollment statistics for each clinic over the past five years. In the row labeled “No. of Applicants,” you will find the number of students who ranked that particular clinic as their **first choice**. The row labeled “No. Enrolled” indicates the number of students accepted into the clinic that year. This statistic includes students who got into the clinic off of the wait list when other students declined their offer or withdrew from the clinic. The chart also indicates whether a particular clinic has accepted students who ranked that clinic as their second or subsequent choice, either because the clinic had more available seats than applications from students who ranked the clinic as their first choice, or because some of the students accepted into the clinic declined their offer or withdrew.

* *Second year students are eligible for this clinic.*

† *Second year students are eligible, but clinic gives preference to students entering their final year of law school.*

Clinic is offered each semester; statistics are cumulative over both semesters.
