

PANELIST BIOGRAPHIES

Professor Jane Stromseth will be discussing her article *Pursuing Accountability for Atrocities after Conflict: What Impact on Building the Rule of Law?*. Professor Stromseth is a professor at Georgetown University Law Center and the Faculty Director of the Law Center's Human Rights Institute. She has written widely on issues of human rights and conflict, is a member of the Council on Foreign Relations, and serves on the editorial board of the American Journal of International Law. After graduating from Yale University Law School, she received a Doctorate in International Relations from Oxford, where she studied as a Rhodes Scholar, and clerked for the Honorable Judge Louis Oberdorfer and Supreme Court Justice Sandra Day O'Connor. Professor Stromseth is the co-author, with Professors David Wippman and Rosa Brooks, of *CAN MIGHT MAKE RIGHTS? BUILDING THE RULE OF LAW AFTER MILITARY INTERVENTIONS*, published by Cambridge University Press in 2006.

Professor Noah Novogrodsky will be moderating the panel. Professor Novogrodsky is currently a visiting professor at Georgetown University Law Center, and is the Director of the International Human Rights Program at the University of Toronto Faculty of Law. After graduating from Yale University Law School, he clerked for Nancy R. Gertner of the District of Massachusetts, received a Bernstein Fellowship to work on human rights and refugee issues in Cape Town, South Africa. Professor Novogrodsky has litigated numerous human rights cases around the world, including an indigenous land-rights case in Belize, and education-rights case in Singapore, and minority rights claims before the European Court of Human Rights.

Professor Gregory Gordon will be discussing his article *Towards an International Criminal Procedure: Due Process Limitations and Aspirations*. Professor Gordon is on the faculty of The University of North Dakota School of Law, where he teaches criminal law, criminal procedure, and international human rights law. He graduated from Boalt Hall School of Law at the University of California at Berkeley, and served as a clerk to the Honorable Martin Pence in the District of Hawaii. After working as a private litigator in San Francisco, he became a prosecutor of Media Crimes at the International Criminal Tribunal for Rwanda in Kigali, Rwanda. From 1999 to 2006, Professor Gordon worked for the Department of Justice, where he spent several years prosecuting war criminals as a Senior Trial Attorney in the Office of Special Investigations.

Ms. Nienke Grossman will be discussing her article *Rehabilitation or Revenge: Prosecuting Child Soldiers for Human Rights Violations*. Ms. Grossman is an attorney at Foley Hoag LLP, where she specializes in representing sovereign country clients in international tribunals including the International Court of Justice and the International Centre for the Settlement of Investment Disputes. Before law school, she was a Dorot Fellow in Israel and a Congressional Hispanic Caucus Institute Fellow in U.S. Senator Tom Harkin's office, where she focused on international affairs and child labor issues. After graduating cum laude from Harvard Law School, she served as law clerk to the Honorable Gerald Bruce Lee in the Eastern District of Virginia.

Mr. Alex Little will be discussing his article *Balancing Accountability and Victim Autonomy at the International Criminal Court*. A graduate of Georgetown University Law Center, Mr. Little served as the first law clerk in the Prosecution Division of the International Criminal Court and, before law school, worked as an associate at The Carter Center, where he worked directly with former President Jimmy Carter on peace efforts in Sudan and Uganda. He is currently clerking for the Honorable Marsha S. Berzon on the U.S. Court of Appeals for the Ninth Circuit.
