

Gianmaria Ajani

Gianmaria Ajani is Dean and Professor of Law at the University of Torino, Faculty of Law, where he teaches Comparative Contract Law, EU law, and Chinese Law. Before joining (1997) the Torino Faculty of Law he was of counsel with the international firm Allen & Overy. Since May 2006 he is Deputy Director of the Centre of Advanced Studies on Contemporary China (www.cascc.eu), an independent research institute founded by the Italian Ministry of Foreign Affairs. Professor Ajani has taught courses on Comparative Law, Russian business law, and EU law as Visiting Professor at UC School of Law, Berkeley between 1988 and 1998, and has advised several international institutions, such as the IMF, the EU Commission, The Council of Europe, UNDP, the ILO, on different aspects of legal reforms in Transition Countries, with particular reference to commercial laws, and to the codification of private law. From 1998 to 2005 he advised the German Agency for Technical Assistance (GTZ), as expert to the Ministry of Commerce and to the Financial and Economic Committee of the National People's Congress of PR of China. In that capacity, he also authored the Draft of the PRC Law to support SMEs. He has been involved in many field researches on legal change in PR of China, Vietnam, Laos, Albania, Russia, Ukraine, Somalia, Eritrea, and Tanzania. Lisa Heinzerling

Lisa Heinzerling joined the Georgetown law faculty in 1993. She received an A.B. from Princeton University and a J.D. from the University of Chicago Law School, where she was editor-in-chief of the Law Review. She clerked for Judge Richard A. Posner on the United States Court of Appeals for the Seventh Circuit and for Justice William J. Brennan, Jr. on the United States Supreme Court. She served as an assistant attorney general in Massachusetts, specializing in environmental law, before becoming a faculty member at Georgetown. She has been a visiting professor at the Yale, Harvard, and Vermont law schools. In 2003 she won the faculty teaching award at Georgetown. She has written numerous books and articles on environmental and administrative law, including (with Frank Ackerman) *Priceless: On Knowing the Price of Everything and the Value of Nothing* (The New Press 2004). She was the lead author of petitioners' briefs in *Massachusetts v. EPA*, in which the Supreme Court held that the Clean Air Act gives EPA the authority to regulate greenhouse gases. Heinzerling just returned to Georgetown after spending two years working for the Obama administration in the U.S. EPA, serving first as senior climate advisor to the EPA Administrator and then as Associate Administrator of the Office of Policy.

Klaus Hoffmann-Holland

Klaus Hoffmann-Holland is University Professor at Freie Universität Berlin, holds the chair of Criminology and Criminal Law and is Managing Director of the Department of Criminal Law at Freie Universität Berlin. He received his law degrees from Justus-Liebig Universität Gießen (Dr. iur. 2000; Dr. iur. habil. 2005, *venia legendi* criminology, criminal law, juvenile justice and corrections). Prior to his appointment in Berlin, he served as a public prosecutor and as a judge. In 2005 he was awarded the Dr.-Herbert-Stolzenberg-Award for jurisprudence. He taught at University of Gießen, the University of Warwick and the Center for Transnational Legal Studies, London. In 2010 he served as a visiting professor in the Faculty of Law of the Hebrew University of Jerusalem, joined the Georgetown University Law Center's faculty as an adjunct professor for the 2010 Summer Law Program in London and was a visiting professor at the Nihon University, College of Law, in Tokyo.

Pascal Pichonnaz

Pascal Pichonnaz is ordinary professor of Law at the University of Fribourg (Switzerland), a post he has held since 2001. He holds the chair for Private Law and Roman Law, teaching contract law, Roman Law and European Contract Law in a comparative perspective. Patented attorney (1994), he earned an LL.M. from the University of California at Berkeley (1997) and was a research Leibnitz fellow in Regensburg (1997-1998), a Robbins Fellow Berkeley in 2005. He was visiting professor in several universities such as Liège [2002]; Pisa [2003]; Glasgow [2003]; Clermont-Ferrand [2007]; Rome II [2007]; Paris II [2008]; CTLS [2009] and Montpellier [2011]. Former member of the board and then Chairman of the European Law Faculties association, he is currently vice-dean and dean for international relations at the Fribourg Law School. Member of the editorial board of several national and international legal periodicals, he is also an international arbitrator (ICC and ad hoc). D. Gordon Smith

BS, Brigham Young University; JD, University of Chicago Law School. Gordon Smith is Associate Dean and Glen L. Farr Professor of Law at Brigham Young University. Prior to joining the law faculty at BYU, Professor Smith taught for five years at the University of Wisconsin Law School, where he also served as Associate Director of the Initiative for Studies in Technology Entrepreneurship (INSITE), and for six years at Lewis & Clark Law School. Before entering academe, Professor Smith clerked for Judge W. Eugene Davis in the United States Court of Appeals for the Fifth Circuit and was an associate in the Delaware office of the international law firm Skadden, Arps, Slate, Meagher & Flom, where he specialized in corporate and securities transactions. Professor Smith is a co-founder of *The Conglomerate* blog, which focuses on issues relating to business, law, economics, and society. His current research focuses on corporate and securities law, with particular emphases on Delaware corporate law and entrepreneurial finance. He has published numerous articles in this area, as well as co-authored a casebook, *Business Organizations: Cases, Problems & Case Studies* (Aspen Publishers 2nd ed. 2008).
