

# EMERGENCY EVACUATION PROCEDURE

## Summary

### **Gewirz Evacuation**

In the event that the Gewirz building is evacuated, the Child Care Center staff and children will follow the fire evacuation routes out of the building to the McDonough building 2<sup>nd</sup> floor podium (outside) or 2<sup>nd</sup> floor atrium (inside).

### **Law Center Campus Evacuation**

In the event that the Law Center Campus must be evacuated, all of the Law Center occupants, including Child Care Center staff and children, will follow the evacuation routes out of the building and walk to the Gonzaga Field (next to Gonzaga High School- North Capitol St.)

### **Area evacuation**

If it is necessary to move farther away, the Child Care Center staff and children will be transported by Law Center Shuttle bus to GU Main Campus, Hoya Kids Learning Center (address, phone number, and directions attached). If, for any reason, this area or direction is not suitable, the Child Care Center staff and children will be transported by Law Center Shuttle bus to Blessed Sacrament Catholic Church (address, phone number, and directions attached).

1. Up Massachusetts Ave. toward Union Station.
2. Left at light onto North Capital Street. Proceed on North Capitol for four miles (past Children's Hospital, past Catholic University/National Shrine, past two cemeteries, etc.) until you reach Missouri Avenue.
3. Make a left on Missouri Avenue. Proceed for approximately 1.2 miles on Missouri Avenue. Note that after about 1.1 miles, when you reach the intersection of Missouri and Georgia Avenues, you will need to make a right on Georgia Avenue and an IMMEDIATE left to continue on Missouri Avenue.
4. At the next intersection, with 13th Street, Missouri Avenue becomes Military Avenue. Proceed on Military Avenue (it will take you through Rock Creek Park) all the way to Connecticut Avenue.
5. Make a right on Connecticut Avenue. Proceed up a few blocks and you will run into Chevy Chase Circle. Blessed Sacrament is on the right as you begin to turn around the Circle
