Resolution 0807: September Appointments for the 2008-2009 Term

WHEREAS Article IV, Section 2(b)(iii) and (iv) requires the Student Bar Association Day Vice President to "act as Chair of the Appointments Committee" and "submit a list of nominees to all Association committees and student-faculty to the House of Delegates for approval";

WHEREAS Article VI, Section 1(c) states that "all Chairpersons of Standing Committees shall be nominated by the Executive Board and confirmed by the House of Delegates";

WHEREAS Article VI, Section 2(c), states that "[t]he Chair(s) of an Ad Hoc Committee must be a Delegate and shall be approved as Chair(s) by the House of Delegates";
