Amanda Allen (US 2009-2010) has joined the Board of Directors for the Abortion Care Network.

Sophia Balemian-Spencer (US 2022-

2023), Associate Counsel on the worker's right team at the Washington Lawyers' Committee, is working on wage theft and sexual harassment cases. Sophia was also featured on the National Reentry Network's Black Table Talk in February.

Sabrina Bernadel (US 2020-2021) is now the Manager of the Education Civil Rights Alliance (ECRA) at the National Center for Youth Law where she protects and advances the rights of historically underrepresented students.

Asees Bhasin (US 2020-2021) will be starting as a Visiting Associate Professor and Murray Fellow at University of Maryland Law School. An article she co-authored, *Antiracist Expert Evidence*, is also forthcoming in the Yale Law Journal (Vol. 134).

Using humour, wit, and honest recollections, Twasiima looks at the ways our histories continue to influence our current times and makes demands of us to sit with both the contradictions and un-comfortabilities that emerge from current events and geopolitical shapings."

Soon-to-be Dr. Pela Boker-Wilson (LAWA 2017-2018) will begin her studies at the Central European University for their Ph.D. Program in Human Rights. Pela was formally inducted into the Committee on the Elimination of All Forms of Racial Discrimination in Geneva, in April this year during the 112th session. Her work began with a review of antidiscrimination efforts by Albania, Mexico, Qatar, the Republic of Moldova, and San Marino. The Committee also presented a Decision adopted under the Committee's early warning and urgent action procedure urging Sudan to prevent further escalation of ethnic violence and racist hate speech. During the session, Pela was appointed to the Working Group on Individual Complaints Mechanisms. Says the Commissioner "With my feet wet, I am eagerly looking forward to the 113th session in August 2024, when I will be given the opportunity and broader mandate to Co-Rapporteur on specific countries and tasks."

Congratulations to **Molly McNulty (US 1988-1989)**, who was promoted to Associate Professor of Public Health Law and Policy at the University of Rochester. Molly reports "Tve been able to maintain my connection to reproductive rights by signing various amicus briefs, filed by public health organizations in *Dobbs* and *Idaho*. I teach a combination of undergraduates, and graduates in the masters in public health program. My courses are Healthcare and the Law, Public Health Law and Policy, Maternal Child Health Policy and Advocacy, and Introduction to Health Policymaking. In the graduate program, I teach Health Policy Lab." Lily Milwit (US 2021-2022) reports, "I'm still a staff attorney at Equal Justice Under Law litigating cases in an effort to end the criminalization of poverty. We won a case in the fall in federal court (E.D. Cal.) challenging Sacramento County's use of a bail schedule that did not account for indigence, resulting in people being held in jail longer solely because they could not afford bail. As a result of our lawsuit, the county is under an injunction enjoining them from utilizing the bail schedule. Local judges must now assess bail on an individual basis, and must consider ability to pay. Our organization also won a handsome attorney's fee settlement from that case (woohoo section 1988) enabling us to continue to litigate these types of cases at no charge to our clients. We also had a summary judgment hearing in D. Montana challenging pretrial fees that do not consider ability to pay. We are hoping to end the practice of requiring exorbitant pretrial fees (which, when not paid, lead to criminal punishment) to people who are legally innocent without any inquiry into ability to pay. I'm returning to UBalt this fall to teach Reproductive Rights & Justice." Lily also visited WLPPFP to present an outstanding seminar on Race and Poverty.

Beverly Mumbo (LAWA 2019-2020) joined

Women's Link Worldwide as Senior Legal Programs Manager where she leads regional advocacy and guides strategic impact litigation on sexual and reproductive rights and health matters.

Ashah Mastullah Mwanga (LAWA 2022-

2023) is bringing her thesis to life! In April, Ashah along with her organization Islamic Women's Initiative for Justice Law and Peace, filed a petition in the Constitutional Court of Uganda requesting that the government operationalize formal Qadhi courts. As Ashah noted in her thesis, family law cases are currently heard by informal Qadhi courts, with little oversight, standards, or implementation of human rights norms. Her petition has received wide coverage as she awaits a hearing date. Ashah also received Georgetown Law's CALI award for excellent performance in Health, Law and Islam.
