**REQUEST FOR DEFERRAL OF TUITION PAYMENT - VA EDUCATION BENEFITS**

This form must be submitted by the tuition payment due date for EACH SEMESTER the student wishes to use their VA Benefits. Please submit this form to the Office of Student Accounts, Room 581, via fax at (202) 662-4069, or Email.

This form must be completed by students who have already applied for the VA Benefits and have submitted a copy of the Certificate of Eligibility to the Office of the Registrar.

Because payments from the VA to the school often arrive after tuition bills are due, the student will not be charged for late fees and service charges only on the amount covered by VA payments. Student must ensure that any portion of their bill that will not be covered by the VA is paid on time in order to avoid the assessment of late payment fees and service charges.

If you make any changes to your schedule after the Add/Drop period has ended, you may have an outstanding balance with the University and/or the VA. You must report any enrollment changes made after the Add/Drop period to the School Certifying Official. If there is an overpayment and the VA sends you a letter requesting repayment, please send a copy of the letter to the School Certifying Official so the University can return any excess funds to VA.
