Resolution 2018-2019-[6]: Fall 2018 Student Organization Budgets

WHEREAS it is the policy of the Georgetown University Law Center that student groups be funded by the Student Bar Association; and

WHEREAS it is the policy of the Appropriations Committee to consider all properly submitted requests for student organization budgets once each semester; and

WHEREAS the Appropriations Committee has adopted and published its Funding Guidelines to assist all student organizations when preparing budget requests; and

WHEREAS 53 organizations submitted budget requests totaling \$175,004.12 in requested funds; and

WHEREAS application of the Funding Guidelines to each budget request and a thorough review of each organizations' historical spending practices resulted in a preliminary budget submitted to the Appropriations Committee; and

WHEREAS the Appropriations Committee repeals the budgets adopted on September 4, 2018;

WHEREAS the Appropriations Committee adopted the following proposed upfront budgets;
