What is Instructional Continuity?

Instructional Continuity (IC) at the Law Center addresses the challenges of continuing classes and coursework without the ability to meet face-to-face using pre-planning and available Georgetown Technology resources.

When should I employ IC?

- Inclement Weather (Georgetown Law Inclement Weather site)
- Campus closure
- Absence of a student or/students due to extenuating circumstances
- Travel by faculty or faculty unable to attend class in person Instructional Continuity will be in effect in an official manner when communicated by Law Center administration via email and text—
- *However, a faculty member may choose to use IC tools at any time on their own for the reasons listed above or others

Q: What should I do first?

A: Plan

Establish a mode of communication with students and administrative staff for use in case of emergency

- Email (Georgetown Gmail)
 - All Georgetown students and faculty have assigned Georgetown Gmail Accounts
- <u>Canvas Learning management System</u> sing the <u>Announcements</u> tool)

 Announcements from Canvas are automatically sent to the Georgetown email address of all individuals enrolled in the course, including administrative staff

Q: What should I do first?

A: Plan

Think about how you would continue class in the event of a disruption, or allow for an alternative to standard in class instruction

Become Familiar with IC Tools: ZOOM



- Zoom is a video conferencing tool that allows users to speak with others in different locations by streaming audio and video.
- Zoom can be used on most devices, including mobile devices
- All Georgetown affiliated individuals with a NetID can claim their Zoom account

*When possible, it is recommended that users visit https://georgetown.zoom.us/ well in advance of a possible IC need to download Zoom and get started

Alternate Use case: Using Zoom in a classroom



Zoom is installed on every classroom PC at the Law Center. Each room has a designated Zoom account.

After turning the room system on, faculty (or students/administrative staff) can:

- Start an Instant meeting and
- Invite participants adhoc

Zoom Classroom Meeting IDs

- You should always use your classroom's meeting ID to Zoom with your class, even if you are not meeting in your classroom.
 - This will insure that the session records and uploads correctly.
- You should only use Zoom to meet with your class during your normally scheduled class time.

Become Familiar with IC Tools: Google Hangouts Chat



- Hangouts Chat allows users to chat either via direct message or in Rooms
- Rooms allow for threaded conversations to separate communications by topic
- Users can video chat as an alternative to Zoom when communicating 1-on-1

<u>Hangouts Chat can be accessed through a web browser</u> or it can be installed as a desktop application.

Become Familiar with IC Tools: Panopto



Panopto is an asynchronous lecture-capture solution, but also a powerful video sharing tool.

- Georgetown Law records all regularly scheduled classes (with some exceptions)
 - Recordings can be viewed in Canvas or via the <u>Panopto@Georgetown website</u>
- Panopto can be supplemented for live in class instruction (students can view lectures if unable to attend class)
- Faculty (or IST) can upload recordings in to Panopto and they can be displayed along with regular lectures
 - Zoom recordings
 - Recordings from mobile or other devices

Become Familiar with IC Tools: Canvas 🛞



- Close to 90% of faculty at Georgetown Law are currently using Canvas If you have never used Canvas, you still have a Canvas course site
- IST provides full support for Canvas including support documentation and training

Keys:

- Think of Canvas as PART of your course, not a supplementary piece
- Imagine trying to run your entire class through email in the case of IC

Become Familiar with IC Tools: Canvas



IC Uses:

- Send Class Announcements
- Collect Assignments, Quizzes and feedback online (Discussions)
- **Grade and give feedback**
- View important course files and links in one location
- **View class recordings**

How do I get IC help?

Let IST know you might require IC assistance in advance (DON'T WAIT)

 - Technician will be assigned to help you
