PRIVATE SECTOR

Response Rate: Out of 414 graduates in the private sector, 77.8% provided salary information (322 graduates)

Salary Range: \$42,000 - \$210,000 Median: \$190,000 \$160,000 - \$210,000 296 graduates \$100,000 - \$159,000 18 graduates \$42,000 - \$99,000 8 graduates

PUBLIC SECTOR

Response Rate: Out of 216 graduates in public sector positions, which include government, non-profit, judicial clerkships, and Entry into Practice (EIP) participants, 51.4% of these graduates provided salary information (111 graduates)
