## Ambassadors for Racial Justice

---

### **Georgetown Law's Juvenile Justice Clinic & Initiative (GJJI)**

Georgetown Law's Juvenile Justice Clinic & Initiative have served youth in the District of Columbia for over 40 years. Together, they aim to raise the quality and scope of juvenile defense practice in the District of Columbia, the Mid-Atlantic region, and nationally through continued direct representation, policy advocacy, and the training of juvenile defenders during law school and throughout their careers. As part of those efforts, the Initiative currently houses NJDC's Mid-Atlantic Juvenile Defender Center and the JTIP Summer Academy on site at Georgetown Law. The Initiative has also launched and expanded a number of racial justice projects designed to advocate for youth of color in the juvenile legal system and train juvenile defenders across the country on emerging racial justice issues, such as implicit racial bias and the intersection of race and adolescence.

### **National Juvenile Defender Center (NJDC)**

NJDC promotes justice for all children by ensuring excellence in juvenile defense. NJDC believes that all youth have the right to zealous, well-resourced representation and that the juvenile defense bar must build its capacity to produce and support capable, well-trained defenders. NJDC, through its national headquarters and its Regional Defender Centers, works to create an environment in which defenders have access to sufficient resources, including investigative and expert assistance, as well as specialized training, adequate and equitable compensation, and manageable workloads. NJDC provides guidance and support to the field including training and technical assistance, policy reform, advocacy, and resource development to juvenile defenders across the nation. NJDC is a proud partner of GJJI on the JTIP Summer Academy training program for juvenile defense attorneys and on racial justice projects, including the Racial Justice Toolkit for Juvenile Defenders and the Ambassadors for Racial Justice Program.

### **Ambassadors for Racial Justice Program**

The Ambassadors for Racial Justice program is a program for defenders who are committed to challenging racial injustice in the juvenile legal system. The Georgetown Juvenile Justice Initiative, in partnership with the National Juvenile Defender Center, hopes to inspire enthusiastic, dedicated frontline juvenile defenders to assume leadership roles in developing strategies to combat racial inequities in their respective jurisdictions and courthouses, and throughout the country. The 12-month-program will (1) encourage and support defenders to challenge racial injustices through legal advocacy, (2) engage defenders in systemic and policy reform, and (3) equip defenders to facilitate difficult conversations about race. By creating a community of juvenile defenders committed to racial justice to share their challenges and successes, the program also hopes to (4) attract and retain a cadre of attorneys of color into the fight for youth justice.

GJJI and NJDC will select up to ten attorneys per year to participate.

## Components of the Program<sup>1</sup>

Ambassadors will remain in residence and in practice in their own local jurisdictions, but participate in the following program components:

- Leadership Retreat weekend in Washington, DC (January 2021)\* (*This training may be virtual depending on the status of the COVID-19 pandemic.*)
- JTIP Summer Academy (June 2021)
  - The JTIP Summer Academy is an annual one-week intensive training program comprised of approximately 20 juvenile law and practice lessons taught by elite trainers recruited from across the country. The program is designed to build community and equip juvenile defenders with skills they can use and share with colleagues in their home states. *Ambassadors are encouraged to apply and will be given priority consideration. Those who have previously attended JTIP Summer Academy will be excused from this component.*
- Monthly conference calls and webinars on topics such as:
  - Strategies for Policy Reform
  - Data Collection 101
  - The Grant Application Process
  - Race and Appellate Advocacy
  - Civil Rights Claims for Racial Justice
  - Coalition Building
  - Black Girls & the Juvenile Legal System
  - Trauma-Informed Decision-Making
  - Ending the School-to-Prison Pipeline
  - Challenging the Criminalization of Adolescent Behavior
  - Police & Youth Engagement
  - Prosecutors as Change Agents
  - Defenders & Implicit Racial Bias: Confronting Our Own Bias
  - The Reasonable Black Child: Race, Adolescence and the Fourth Amendment
  - Raising Race in My Jurisdiction (Case Rounds)
- Mentoring by policy advocates, litigators, and trainers
- Membership in a dedicated Ambassadors for Racial Justice listserv
- Development and exchange of resources, such as sample legal pleadings
- Certification as a trainer on ways all youth defenders can raise race as part of their advocacy
- Possible expert site-visits to Ambassador's home jurisdiction for court observation

### **Defenders Must:**

- Carry a significant juvenile defense caseload in their jurisdiction, or otherwise demonstrate current experience, commitment, and engagement in juvenile justice reform, and strong partnership with juvenile defenders (e.g., juvenile appellate defenders, juvenile policy experts in defender offices).
- Demonstrate a commitment to expressed-interest advocacy on behalf of all youth.
- Commit to completing one capstone project of their own design. Possible projects may include:
  - Hosting/leading a training related to racial justice for juvenile defenders in their local jurisdiction;
  - Spearheading legislative reform in their local jurisdiction;
  - Preparing a social media campaign related to racial equity and youth rights; or

- Creating an internship program that encourages college/law students of color to pursue careers in juvenile defense work. Internship programs may be paid, pro bono or for school credit. Ambassadors may partner with any regional defender center to launch internship program.
- Participate in all components of the program.

### **Expected Outcomes**

- Empower juvenile defenders with the training, resources, and information to fight the over-policing, over-criminalization, and school exclusion of youth of color through case litigation and systemic policy.
- Grow the number of juvenile defenders and juvenile justice advocates equipped to train other defenders on raising race and facilitating difficult conversations about race.
- Raise the level of practice among juvenile defenders committed to racial justice across the country and improve outcomes for youth of color nationally.
- Embolden a group of well-trained, diverse juvenile defenders and juvenile justice advocates who may go on to become policy advocates, judges, and legislators, to represent minority viewpoints, empower communities of color, and systemically reform our juvenile legal system.
