It will also focus on the many pending lawsuits challenging those policies – lawsuits currently working their way up to the Supreme Court. Professor Schrag directs Georgetown's asylum law clinic (the Center for Applied Legal Studies (CALS)) and is the author of five books on asylum policy and adjudication, most recently Baby Jails: The Fight to End the Incarceration of Refugee Children in America (2020).
