# **Georgetown Justice Fellowship - Application Instructions**

Law is but the means, justice is the end.

Georgetown University Law Center is pleased to offer Georgetown Justice Fellowships for 2021 JD graduates interested in beginning their careers in public interest law. The Georgetown Justice Fellowships provide partial funding of \$20,000 towards one year fellowships at nonprofits, government offices, and other eligible host organizations, helping create a launching pad for new public interest attorneys to begin their careers.

To apply for a Georgetown Justice Fellowship, applicants must meet the eligibility criteria outlined below and submit a complete application by **April 1, 2021**. Georgetown Justice Fellowship recipients will be announced in May 2021.

#### Eligible students are:

- Graduates in the JD Class of 2021 completing their degree no later than May 2021
   Note: LLM students and students completing a joint degree program that will not confer a JD in May 2021 are not eligible.
- Planning to take the Bar exam on or before July 2021 (with limited pre-approved exceptions) Pre-approval may be sought by emailing <a href="mailto:opics@georgetown.edu">opics@georgetown.edu</a> with an email titled "Georgetown Justice Fellowship Pre-Approval Request"
- Otherwise unemployed post-graduation for the term of the Georgetown Justice Fellowship
- Able to commit, if offered the fellowship, to full-time work at their host (at least 35 hours per week) for a full one year term
- Willing, if accepting the fellowship, to withdraw all other applications for employment for the oneyear term of the fellowship

#### Eligible host organizations:

- Must be US-based nonprofits with 501(c)(3) status or local or state government offices; Note: Federal government agencies and international nonprofits, government agencies, or courts/tribunals may be eligible, but applicants must obtain pre-approval before applying with such an employer. Pre-approval may be sought by emailing opics@georgetown.edu with an email titled "Georgetown Justice Fellowship Pre-Approval Request"
- Must be able to sign the Georgetown Justice Fellowship Memorandum of Understanding (MOU) (<u>Sample</u> Georgetown Justice Fellowship MOU); and
  - Note: Applicants with hosts who request changes to the sample MOU must have the changes approved by Georgetown before the application is submitted. A negotiated MOU may be sought by emailing a redlined version of the MOU with suggestions made to <a href="mailto:opics@georgetown.edu">opics@georgetown.edu</a> with an email titled "Georgetown Justice Fellowship Revised MOU Request"
- Must commit to hire the fellow at a salary of at least \$40,000 and to provide the fellow with the same benefits that the host organization would ordinarily provide to an employee at the fellow's level (e.g., other entry-level fellows, entry-level attorneys with similar levels of experience, etc.), for a term of at least one year.

#### Eligible fellowship work:

- Is law-related public interest work that either requires Bar passage or for which a JD is a preferred qualification.
- Is either project-based (e.g., a new initiative designed by the fellow) or a staff attorney-type position.
- Is not partisan political campaign activity (i.e. involving tasks in any way related to a political campaign or political action committee) or lobbying.

#### Priority will be given to applicants who can demonstrate:

- The applicant's longstanding commitment to public service and to Georgetown's motto: "Law is but the means, justice is the end"
- The impact of this fellowship on serving unmet needs, expanding services, moving forward cause, or otherwise increasing justice
- The applicant's commitment to a future career in the public interest that will be supported by this fellowship
- A strong commitment on behalf of the host organization to train, mentor, and otherwise support the work of the fellow

## **Application components:**

- 1. Georgetown Justice Fellowship Application CoverSheet
- 2. Two essays answering the following questions:
  - a. What is your anticipated work and how will the fellowship allow you to serve unmet needs, expand services, move forward a cause, or otherwise increase justice? (500 words maximum)
  - b. How will this position set you up for a career in public interest? (500 words maximum)

    Note: If preferred, the applicant may submit one letter of interest that responds to both questions and that is 1000 words or less.
- 3. Resume detailing public interest experience (two page resumes welcome)
- 4. Host organization letter of support including:
  - a. An acknowledgement that host will:
    - i. Receive a payment of \$20,000 from Georgetown;
    - ii. Agree to the terms of the Georgetown Justice Fellowship Memorandum of Understanding (MOU) (or to the terms of a pre-negotiated MOU);
    - iii. Be the employer of the fellow;
    - iv. Employ the fellow for at least one year in a position that requires Bar passage and/or a JD (or strongly benefits from them);
    - v. Offer liability insurance as needed; and
    - vi. Consider the fellow for full-time paid employment if a position/funding becomes available during or following the fellowship period.
  - b. A description of the supervision and training/support the fellow will receive.
  - c. Information about the salary and benefits the host will offer the fellow (annual salary must be at least \$40,000).
  - d. 501(c)(3) tax-exempt status qualifying letter or equivalent tax-exempt status documentation for international organizations.
- 5. Letter of Recommendation from one faculty member or former employer who can speak to the student's commitment to public service and the importance of the fellowship.

6. Unofficial transcript that lists all courses, including experiential.
