WHEREAS it is the policy of the Georgetown University Law Center that student groups be funded by the Student Bar Association's limited funds; and

WHEREAS it is the policy of the Appropriations Committee to consider all properly submitted requests for student organization budgets once each semester; and

WHEREAS the Appropriations Committee has adopted and published its 2021 Funding Guidelines to assist all student organizations when preparing Fall 2021 budget requests; and

WHEREAS 58 organizations submitted budget requests for the Fall of 2021 totaling \$304,004 in requested funds; and

WHEREAS SBA's Fall 2021 allocation for student organizations is \$65,000; and

WHEREAS SBA diverted \$10,000 in diversity funds for additional funding; and


WHEREAS application of the Appropriations Guidelines to each budget request and a thorough review of each organizations' historical spending practices and value statement resulted in a preliminary budget submitted to the Appropriations Committee; and
