- ✤ Academic Affairs (Ida)
 - Working on (1) trying to extend P/F Resolution, which failed... a couple of COVID measures we will probably see extended; (2) in sync option for parents but does not seem like that is going to be happening
 - P/F elections by September 24 but haven't voted on whether P/F will stay so will be electing on the last day of classes
 - Hybrid classes going on at 7:30 am and other hybrid classes going on but they don't think it's pedagogically sound to extend it to everyone
 - Thinking about increasing P/F credits to 10 but won't happen this semester
- ABA and DC Bar Liaison (Braydon)
 - o Amy working with Matthew to create a Federal Bar Association chapter
 - Picking up ABA materials and fliers tomorrow from Dean of Students Office and will send announcements

- Resolutions
 - 10: Student Organization Budget Resolution
 - Suzanne introduced the resolution
 - Student Org requests went up much more than SBA budget went up
 - Create UBI and then cut the remainder by the % difference between the requests and the SBA budget and then added diversity funds
 - Alyssa Jones speaks in favor of the resolution
 - Cameron moved to close debate seconded
 - Vote by general consent adopted

Open Forum:

- Open Forum
 - Want to echo that evening students are very upset that they are forced to come to class (Madeline)
 - o Disappointed in treatment of classmates who expressed concerns (Madeline)
 - o Potential to organize faculty who are unhappy with the policy (Madeline)
 - Evening student meeting push for the inclusion of immunocompromised and people caring for the immunocompromised (Madeline)
 - o Been in classes with no masks, no social distancing so not super safe (Madeline)
 - Might be nice for organizations to mirroring our asks SBA meetings as Zoom links, bar reviews at outdoor bars (Madeline)
 - o Lots of issues with InternX platforms (Cameron)
 - Divergent opinions on COVID policy from both ends of the spectrum and so we should be measuring the temperature maybe with a survey to see what cultural problems exist or to have data for the admin (Christian)
 - Not comparing 2 equal sides (Ida)
 - Day and evening students have different concerns (Diane)
 - Meshing policies that aren't consistent and isn't being enforced (JD)
 - Professor said they policies wouldn't line up (JD)
 - Eating and drinking policy not being enforced (Malcolm)
 - Guest lecturer policy does one exist? (Malcolm)
 - Something they are actively working on (Jade)
 - All guest speakers have to be vaccinated (Madeline)

- Clinics clients that aren't vaccinated have to be in "more ventilated rooms" (Ida)
- Admissions Office policy on distributing merit scholarships the way it's being done now is unfair... only considered for them if you send them an email and ask for them, don't go to who need them the most or deserve them the most (Jace)
