#### **GENERAL ORIENTATION QUESTIONS**

##### **Is attendance mandatory at all Orientation sessions? Can a student skip part of Orientation?**

Students are expected to attend all mandatory academic-related Orientation sessions:

- Deans' Welcome
- Myths and Realities of Law School
- Introduction to the First-Year Experience

Students who need to make a request to miss any of the above sessions should email [lawdeanofstudents@georgetown.edu](mailto:lawdeanofstudents@georgetown.edu).

Attendance at all other community events is not mandatory (including the concurrent breakout sessions, the Faculty Moot Court, and Peer Advisor meals), but you're *strongly encouraged* to take advantage of all the great things going on and to connect with your new Georgetown Law community.

##### **When/where should I check in?**

Students should plan to check in on the second floor of McDonough at some point prior to their respective section welcome. The welcomes sessions are:

- Section 1 – 10:00 a.m. to 11:00 a.m.
- Section 2 – 11:15 a.m. to 12:15 p.m.
- Section 3 – 12:30 p.m. to 1:30 p.m.
- Section 4 – 2:30 p.m. to 3:30 p.m.
- Section 5 – 3:45 p.m. to 4:45 p.m.

For example, Section 1 should be checked in by 10:00 a.m. in order to attend the welcome session, but section 5 can check in up until 3:45 p.m., even if attending other optional sessions/events during the day.

##### **Can a student go to another section's Orientation session?**

Students are expected to attend the mandatory academic Orientation sessions that are specifically scheduled for their section. Should a conflict arise and a student is unable to attend one of their section's programs, a request must be made to [lawdeanofstudents@georgetown.edu](mailto:lawdeanofstudents@georgetown.edu).

##### **What sessions may family members/significant others attend?**

Due to space limitations, ALL sessions are for incoming first-year JD students only.

##### **Is there a dress code for Orientation?**

There is no dress code for Orientation and students should dress comfortably as the weather will likely be quite warm.

##### **Does a student have to register to attend the Faculty Moot Court program? Is it mandatory?**

Registration is not required. Attendance is not mandatory but highly recommended – a highlight of Orientation Week! The program begins after the Peer Advisor dinner and will be taking place at the

Shakespeare Theatre Company's Harman Hall, within walking distance of campus.

### **What is the Faculty Moot Court case?**

The program features a mock argument of a case that will be heard by the Supreme Court this coming term. This year's case will be *303 Creative LLC v. Elenis*.

### **Does a student have to register to attend a Faculty Talk?**

No, all faculty talks are open on a drop-in basis.

### **Does a student have to register to attend a Faculty Tour?**

Some tours do require pre-registration. See the August 15 email from the Office of the Dean of Students for more information on these tours. Otherwise, you are welcome to join one of the tours that will take place on Tuesday, August 23 that do not require any pre-registration.

## **COVID TESTING, VACCINATION, & MASKING**

All students will need to [take a COVID-19 test](#) between 48 hours before and 24 hours after arriving on campus. Failure to get an arrival test may result in disciplinary action.

- Residential students: A PCR test is required.
- Non-residential students: A PCR test is preferred, but an [antigen test](#) will be accepted.

If you would like a PCR test on campus, you must [register with One Medical](#).

All students are required to be fully vaccinated against COVID-19. Please see the [Georgetown University Vaccine Requirement](#) page for more.

The Law Center operates under a mask-optional policy, with the limited exceptions noted below:

- Individuals must wear a mask while on University-sponsored public transportation (e.g., GUTS buses, shuttles, vans).
- Individuals must wear a mask in University healthcare facilities (e.g., Student Health Center, CAPS, One Medical testing sites).
- Individuals in, or recently released from, quarantine or isolation must wear a mask for the full 10 days from the date of exposure or infection, consistent with DC Health guidance and CDC guidance.
- Individuals with exemptions or accommodation plans that include enhanced public health measures should continue to abide by those measures, as currently in place.

## **MOBILE GOCARD**

The GOCard is the official identification card of Georgetown University and much more! It's the way to pay for your purchases on and off campus. Use your GOCard to buy books, food, supplies, as well as gain access to academic buildings and residence halls.

## **BOOKS & COURSE MATERIALS**

**Where can I find out what books I need for my courses?**

### **Buying Textbooks**

Once you have your schedule of courses, you can search the Georgetown Law Bookstore for your course materials by Course Number. Course materials may also be posted in Canvas.

You can purchase your textbooks from the Georgetown Law Bookstore. The Bookstore is located next to the Sport and Fitness Center. For current hours, please call the Bookstore at (202) 662-9676.

### **Readings and Textbooks on Course Reserve**

Faculty may request that recommended readings be placed on course reserve. Course reserve materials may be checked out for a period of three hours. They may be renewed at the Williams Circulation Desk, unless another student has requested the same item.

## **CLASS READINGS & WEBSITES (from JD Academic Services)**

**Where can I find my first class assignments?**

Professors typically assign readings to be completed in advance of the first day of class. Faculty Support will begin posting the first class assignments on the First Class Assignments Canvas page on August 15. Some faculty also list their first assignment on their individual Canvas pages. Professors may also email assignments in advance of the first class, so be sure to check your @georgetown email address.

If you have any questions about the assignment, contact your professor directly.

## **LOCKERS**

**How can I register for a locker?**

Students will be able to request a locker from August 23 through September 2, by the Chapel on the first floor of McDonough.

## **PARKING**

**Can I park on campus?**

If you plan on driving to campus, student daily parking is available on a first-come, first-served basis in the McDonough Hall garage. Students may only park on the P-2 level in spaces marked for student parking.

The parking rate is \$9.50 per entry (payable by GOCard); free after 4:30 p.m. Free parking is available on weekends. However, overnight parking is not permitted.

Please note that there is ongoing concrete work in the McDonough Hall parking garage. Spaces will be unavailable on a rotating basis until the project is completed. Because there will be fewer spaces

available we expect there to be congestion. A parking attendant will be monitoring parking daily to ensure compliance. Please do not enter the garage if you see the "student parking full" sign displayed at the garage entrance.

## **PRINTING, PHOTOCOPYING, & SCANNING**

### **Where can a student go to make copies, scan a document, etc.?**

You can find information on printing as well as printer locations on the [Student Printing](#) page. You will need your GOCard, SaxaNet wifi access, and a [Papercut](#) account in order to print on campus.

## **STUDENT HEALTH & HEALTH INSURANCE**

### **Where should a student go if they have questions about immunizations?**

Use the [Student Health Portal](#) to review your immunization status and to see if you are meeting all of the university requirements. If you have a question, send a secure message to the student health team through the portal. ### **Will the Student Health Center on the Law Center campus be open during Orientation?**

The Student Health Center on the Lower Level of Gewirz will not be open during Orientation week for medical treatment. The clinic will be open on Thursday, August 25th from 9:00 a.m. to 4:00 p.m. for the Immunization Clinic.. Students in need of medical care may visit the Student Health Center on main campus and they may set up an appointment by calling 202-687-2200. The Student Health Center on the law campus will open after classes begin (exact date TBA).

### **When do students receive their Westlaw and LexisNexis passwords?**

Passwords to LexisNexis and Westlaw will be given out by the Williams Library staff via email after Orientation begins.

## **WIRELESS INTERNET PASSWORDS & EMAIL**

### **How do students receive the password information to access the Law Center's wireless network?**

Georgetown University's secured wireless networks are SaxaNet and eduroam. When you connect to them, your wireless signal is encrypted, securing your connection against eavesdropping and possible data theft. To connect, you must be on the Law Center campus, have an active NetID, and know your Georgetown University password. Gulaw-secure is a legacy wireless network. Our secured wireless networks support devices that comply with the 802.11n Wi-Fi and WPA2 authentication standards.
