### **OVERVIEW**

The National SJD Roundtable is a forum for SJD students at any stage of their doctoral studies to present their academic work, attend other presentations, and share thoughts about legal academia. Like all academic fora, it encourages free and open inquiry and exchange of ideas.

SJD students are invited to submit material from or related to their dissertations. This might be full dissertation chapters or articles but may also include partial chapters or articles, dissertation proposals, thesis statements and outlines.


Each presenter has 30 minutes in which to present and receive comments. We recommend keeping your presentation to 10 minutes to maximize time for discussion. The experience is akin to poster-board or exhibition talks at academic conferences rather than workshops with lengthy substantive and scholarly discussion.

We assign presenters and participants to specific sessions throughout the day, and try to match people based on subject matter but this is not always possible. We hope you will appreciate the value of learning about new topics!

For presenters, the Roundtable helps sharpen your central arguments and to practice organizing ideas, offering them succinctly and clearly. Participants, in turn, learn how to give feedback that is thoughtful, friendly and respectful.

The Roundtable is also a wonderful networking and social event for SJD students!

## Presenting and Providing Feedback

In addition to practicing your presentation skills, you will experience what it is like to receive varied comments on your work and how to give thoughtful feedback on other people's work. An important goal of the Roundtable is to help you become better at these crucial professional activities. Here are some recommendations:

- Please read the submitted material in advance of the presentations you will be attending.
- In commenting on another's intellectual work, it is helpful to suggest ways to strengthen and clarify arguments.
- Try to avoid advising what you think the dissertation should be.
- Presenters are encouraged to specify the kind of feedback they would find most helpful. This may be on key ideas, structure, or issues you are struggling with.
- Alternatively, presenters may indicate that they welcome all types of feedback.
- Either way, remain open to specific suggestions you might not have thought about at this stage of your research.
- Please be respectful of speakers and the audience by arriving at a session on time and staying for the duration. The Roundtable schedule has 15 minute breaks between events and each session.
- Each session will have a moderator to manage discussion and keep time.
- Remember, everyone has insights to offer based on their experiences, and we can all learn from each other.
