## **Our Newest Clinic Focused on Racial Justice**

Professor Janel George joined Georgetown Law as the founding director of our newest clinic, the Racial Equity in Education Law and Policy (REELP) Clinic which launched in Spring 2022. Professor George brings with her a wealth of experience in legislative law and policy advocacy. The REEL Policy Clinic engages in policy advocacy on behalf of clients to advance racial equity in education, which includes nationally focused organizations, smaller local groups and even student-led organizations. This work includes addressing issues that disproportionately impact the educational experiences and outcomes of students of color, including discriminatory school discipline practices, police presence in schools, school segregation, resource inequities, narrow and punitive assessments, and educational approaches that focus on remediation of students of color.
