

**GEORGETOWN LAW**  
**TUITION REFUND SCHEDULE - ACADEMIC YEAR 2023 - 2024**

Entering first-year students who want to withdraw from Georgetown Law prior to the deadline set by the Office of Admissions and/or prior to first-year Registration and Orientation must give notice in writing to the Office of Admissions via email to [hotline@law.georgetown.edu](mailto:hotline@law.georgetown.edu) (J.D. students) or [llmadmis@law.georgetown.edu](mailto:llmadmis@law.georgetown.edu) (LL.M. or S.J.D. students)

All continuing, transfer, visiting, and non-degree students who want to voluntarily withdraw from Georgetown Law must notify the Office of the Registrar via email to [lawreg@georgetown.edu](mailto:lawreg@georgetown.edu)

Tuition refunds will be calculated from the date the Office of Registrar and /or the Office of Admissions receives written notification of a student's withdrawal from a on-campus course or courses or from Georgetown Law.

**For Individual Course Withdrawals** - Only students charged tuition by the credit hour may receive a refund in the event of an individual course withdrawal, and only where otherwise refundable under the tuition refund schedule.

<b>FALL 2023 - All Students</b>	
Orientation Week, August 21-25	100%
August 28 - September 5 (first week of classes - add/drop)	100%
September 6 - 12	80%
September 13 - 26	50%
September 27 - October 11	25%
After October 11	0%
<b>Spring 2024 - Week One Courses</b>	
Prior to January 8	100%
After January 8	0%

\*Week One courses begin Monday, January 8th. Students who wish to drop a Week One course without charge or transcript notation must do so by emailing the Office of the registrar prior to the second class session.

<b>SPRING 2024 - Regular-Semester Courses - ALL STUDENTS</b>	
Prior to January 16	100%
Add/Drop and Waitlist Activity, January 16 - 23	100%
January 24 - 30	80%
January 31 - February 13	50%
February 14 - February 27	25%
After February 27	0%
<b>SUMMER 2024**</b>	
Prior to first class date	100%
First week	80%
Second week	50%
Third week	25%
After third week	0%

\*\*A student will be permitted to drop a Summer course after the first class meeting, without a transcript notation, if the student submits a written request to the Office of the Registrar prior to the second class meeting. In these instances, students who are charged tuition by the credit hour will receive a 100% refund for the course

**Important Note:** Refunds for students who have federal student loans and who withdraw are governed by the refund procedures established by the Department of Education for return of student loan proceeds to the appropriate federal student loan lender. Students borrowing federal loans should consult with the Financial Aid Office prior to initiating the withdrawal process. The regulations require a student to "earn" federal financial aid on a daily basis as the term progresses. For example, if there were 100 days in the semester, a student withdrawing on the 30th day will have earned 30% of their federal aid. As of the 60% point in a given semester, the student is considered to have earned 100% of the federal loans borrowed for that term. Withdrawal before then requires Georgetown Law to return loan funds to the lender even though, based on the tuition refund schedule show above, this may result in the student owing a balance to Georgetown Law. Before officially withdrawing, consult the Financial Aid Office for more information on the financial implications of your decision. The Georgetown Law tuition refund policy is subject to change at any time due to federal regulatory and/or school policy revision or updates.
