### ELIGIBILITY

- Our **LL.M. programs** are open to both U.S.- and foreign-educated lawyers. **U.S.-educated candidates** must have received a J.D. degree from a law school accredited by the American Bar Association.
- **Students educated outside the United States** must have already completed the university portion of their legal education and received the degree required for admission to practice law in their country.


### SPECIAL OPPORTUNITIES FOR LL.M. STUDENTS

For all foreign-educated students, we offer the highly popular **LL.M. Summer Experience**, a program that enables students to earn up to four academic credits that count toward the **New York Bar**.

The LL.M. Post-Graduate Public Interest Fellowship Program provides opportunities to Georgetown Law LL.M. students who are interested in gaining experience post-graduation with a public interest employer or international organization.

LL.M. students can also participate in journals, moot court competitions, and student organizations.

The **General Studies LL.M.** has no specific course requirements, allowing you to assemble a program of study from Georgetown Law's unrivaled selection of courses.

The **International Legal Studies LL.M.** is similarly flexible, providing you the opportunity to choose courses from one of the largest international law curricula of any U.S. law school, while still having room to take elective courses.

You can also establish strong foundations in the U.S. legal system and its research and communication methods through courses specifically designed for these purposes, including Introduction to U.S. Legal Systems and U.S. Legal Research, Analysis and Writing.

Dedicated **academic advisors** are available to assist you in selecting courses to meet your individual professional goals and interests.

## **INNOVATIVE TWO-YEAR LL.M.**

Established more than a decade ago as the first program of its kind in the U.S., Georgetown Law's Two-Year LL.M. with a Certificate in Legal English offers foreign-educated lawyers the opportunity to focus more intensively on a specific area of law while achieving mastery in written and oral legal English. All classes are taught by Georgetown Law faculty and Legal English faculty.

You begin as a member of the LL.M. class, completing required courses in the Legal English curriculum in your first year, along with courses from the LL.M. curriculum. During the summer, you can continue your legal studies in a number of ways, such as participating in the Georgetown LL.M. Summer Experience in Washington, D.C., taking classes in the Georgetown London Summer Program or pursuing an internship. In the second year, you select your own course of study from Georgetown Law's 300+ graduate course offerings.

**G**eorgetown's LL.M. in International Business and Economic Law (IBEL) enables students to gain a deeper understanding of how national and international law shapes trade, finance and world markets.

## **FLEXIBLE CURRICULUM**

As an **IBEL student**, you are required to take a class in corporations, at least one class related to international regulation, and at least one class related to international business. You have the opportunity to select your specialized classes from more than 70 courses related to business and international law, and elective credits from Georgetown Law's entire curriculum.

## **GLOBAL EXPERTISE**

Our faculty includes renowned scholars in areas ranging from sovereign debt to cryptocurrency, who are involved in real-world policymaking and advocacy. Many students have worked for U.S. and international economic organizations, others have worked for our Professors such as Professor Anne Marie Whitesell, former secretary general of the ICC International Court of Arbitration.

Faculty members are also highly involved in organizing international conferences and symposia on cutting-edge issues involving international law and business. Professor Chris Brummer, faculty director of the Institute of International Economic Law (IIEL), is the founder of DC Fintech Week, a global forum on financial technology.

## **SPECIAL OPPORTUNITIES**

IBEL students are eligible to apply for specialized **fellowships and scholarships** related to their interests. The IIEL Fellowship Program, for example, brings together a select group of Georgetown J.D., LL.M. and doctoral students with scholars, policymakers and practitioners to discuss new policy developments in international economic law.

**T**he Environmental and Energy Law LL.M. degree program encompasses environmental, energy, natural resources, land use and food law. Our students gain practical skills and first-hand insights into some of the most compelling environmental issues facing the U.S. and the world.

## MELDING THEORY AND PRACTICE

The curriculum combines diverse and rigorous pedagogy with practical, real-world opportunities available only in Washington, D.C. In the first semester, all students are enrolled in a specialized Environmental Lawyering Seminar, giving you the opportunity to engage in high-level idea exchange and relationship building with your classmates. You will also hone your legal skills through a required practicum or internship.

Students can create their own specialized plan of study suited to their passions and career goals. Courses range from environmental law to energy law and natural resources law to specialized seminars on environmental justice, water law, wildlife law, food and drug law, energy trading, and the intersection of business, sustainability and human rights.

## GO BEYOND THE CLASSROOM

Students are required to complete an externship or practicum course. In Washington, D.C., opportunities for externships abound, from private firms and energy companies to government agencies, NGOs, and international organizations.

## UNEP FELLOWSHIP

The only scholarship of its kind worldwide, the GESL Fellowship allows public sector lawyers from developing countries to earn a Georgetown LL.M. and then gain international legal experience with a posting at UNEP's headquarters in Nairobi, Kenya. The fellowship covers the full cost of tuition and travel. Fellows must commit to return to their home country to continue working in public sector environmental law and policy for no less than three years following completion of the program. ## **TECHNOLOGY LAW & POLICY LL.M.**

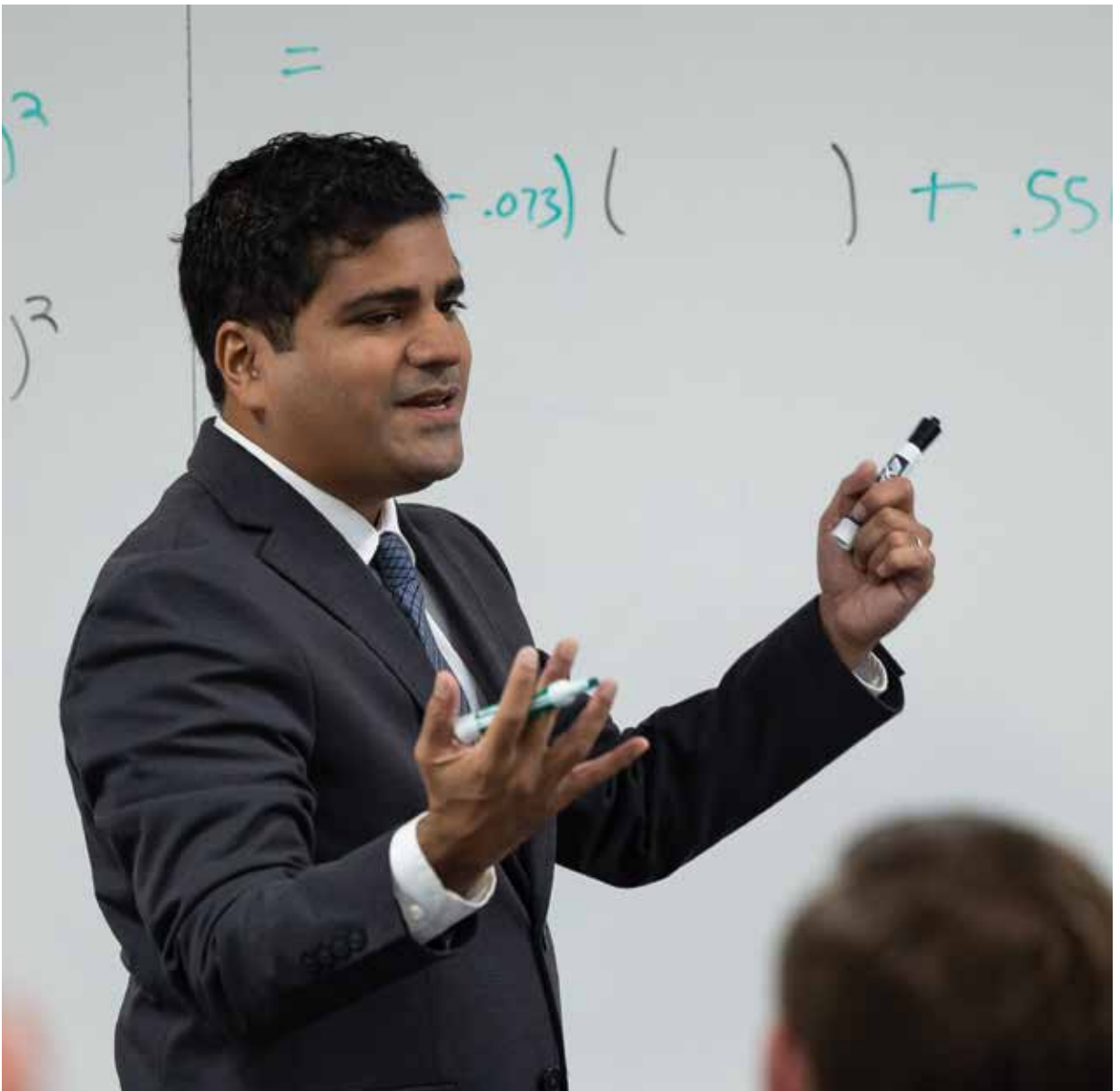
Georgetown's LL.M. in Technology Law & Policy is designed both for recent law school graduates interested in entering technology-related fields and for mid-career lawyers and policymakers seeking to hone their expertise in this specialty. The extensive curriculum includes courses ranging from Information Privacy Law; to Technology, Artificial Intelligence and the Law; to Cybersecurity.

## **MASTER OF LAW AND TECHNOLOGY**

The laws and policies related to technology are increasingly relevant to those outside the legal field, including policy advisors, journalists, product developers, entrepreneurs, civil society advocates and others.

Georgetown's Master of Law and Technology (M.L.T.) program is designed for non-lawyers who need to understand this quickly evolving area of law. In addition to required courses in Foundations of American Law and Digital Law & Policy, the curriculum includes a wide selection of courses such as Free Press, Antitrust, and Policing in the 21st Century: Law Enforcement, Technology & Surveillance.





### **INSTITUTE FOR TECHNOLOGY LAW & POLICY**

Georgetown's Institute for Technology Law & Policy is dedicated to training students, educating policymakers, and informing the public about the key challenges and opportunities at the intersection of law and technology.

The institute provides a uniquely valuable forum in Washington, D.C., for policymakers, academics and technologists to discuss the most pressing issues and opportunities in technology law today — sponsoring an annual calendar of international conferences, and symposia. Our innovative programs explore the intersections of health and law, including global health governance, health and human rights, food and drug law, access to health care, and legal interventions to prevent and control infectious and non-communicable diseases.

## MULTIDISCIPLINARY ADVANTAGE

As a student you can draw on **Georgetown's world-class resources** at the School of Medicine, School of Nursing and Health Studies, McCourt School of Public Policy, School of Foreign Service and more. You also have the opportunity to pursue a joint LL.M./M.P.H. degree with the top-ranked Bloomberg School of Public Health at Johns Hopkins University.

## NATIONAL AND GLOBAL HEALTH LAW LL.M.

This degree program features a specialized Global Health Law course that explores the roles that law, lawyers, and legal institutions play in public health across the globe. You work with a dedicated academic advisor to select additional courses from Georgetown Law's extensive health law curriculum.

## GLOBAL HEALTH LAW AND GOVERNANCE LL.M.

In this unique program, you spend the fall semester at Georgetown Law and the spring semester at the Graduate Institute of International and Development Studies in Geneva, Switzerland. In addition to coursework, you complete either an approved internship or a dissertation.

As a degree candidate, you are eligible to apply for a Global Health Law scholarship. Global Health Law Scholars receive full- or partial-tuition awards.

**G**eorgetown's program in national security law offers an unmatched combination of strengths: faculty with real-world experience in the field, unique opportunities such as our annual National Security Law Crisis Simulation, and an alumni network of high-level practitioners, including current U.S. Director of National Intelligence Avril Haines (L'01).

## THE LL.M. PROGRAM

The National Security Law LL.M. program at Georgetown is a boutique specialization designed for mid-career national security law practitioners interested in developing specific expertise, seasoned lawyers transitioning to the field, foreign-trained attorneys with knowledge of international and U.S. law, and a small number of recent law graduates.

## PROSEMINAR IN NATIONAL SECURITY


The **Proseminar in National Security Law** serves as the gateway course for National Security Law LL.M. students, and is one of the distinguishing features of the program. The Proseminar prepares you to engage in direct dialogue among different parts of the national security community, including civilian and military government agencies, human rights organizations, law firms, contractors and civil liberties organizations.

## A WEALTH OF RESOURCES

Georgetown's Center on National Security Law brings a holistic and multidisciplinary approach to addressing some of the most pressing concerns in national security law and policy. The center recently launched a new **360 Innovation Incubator**, a problem-solving lab for complex real-world security problems.

If you are interested in national security scholarship, the Journal of National Security Law & Policy offers the opportunity to serve as an LL.M. Peer Reviewer, vetting and reviewing manuscripts for the renowned publication.

**T**he Office of Graduate Admissions is here to help at every step of the application process.

## **SELECTION CRITERIA**

Every year we receive thousands of applications from more than 100 countries. We review each application in a holistic manner, considering academic and professional qualifications along with many other qualitative factors. We understand that there is more to an applicant than just numbers.

Georgetown Law has a rolling admissions process, which means it is to your advantage to apply as early as possible.

## **APPLICATION PROCESS**

Georgetown Law strongly prefers that applicants apply online via the LSAC electronic application. LSAC needs time to process materials once received at its offices, so applicants should send their materials to LSAC well in advance of application deadlines.

If you want to apply with a traditional paper application or are unable to apply via LSAC, you may do so.

Please note that there are separate applications for those applicants who received their first degree in law in the United States (i.e., Juris Doctor) and for those who received their first degree in law from another country.

## **FINANCIAL ASSISTANCE**

Students who are U.S. citizens or permanent residents may apply for financial aid in the form of loans. For more information please visit our Financial Aid webpage.

As part of the student visa application process, international students admitted to Georgetown Law must be able to demonstrate the ability to finance their entire course of study. We encourage international students to begin the search for financing as early in the process as possible, by exploring loan and scholarship options that may be available through your home country government or other scholarship organizations.

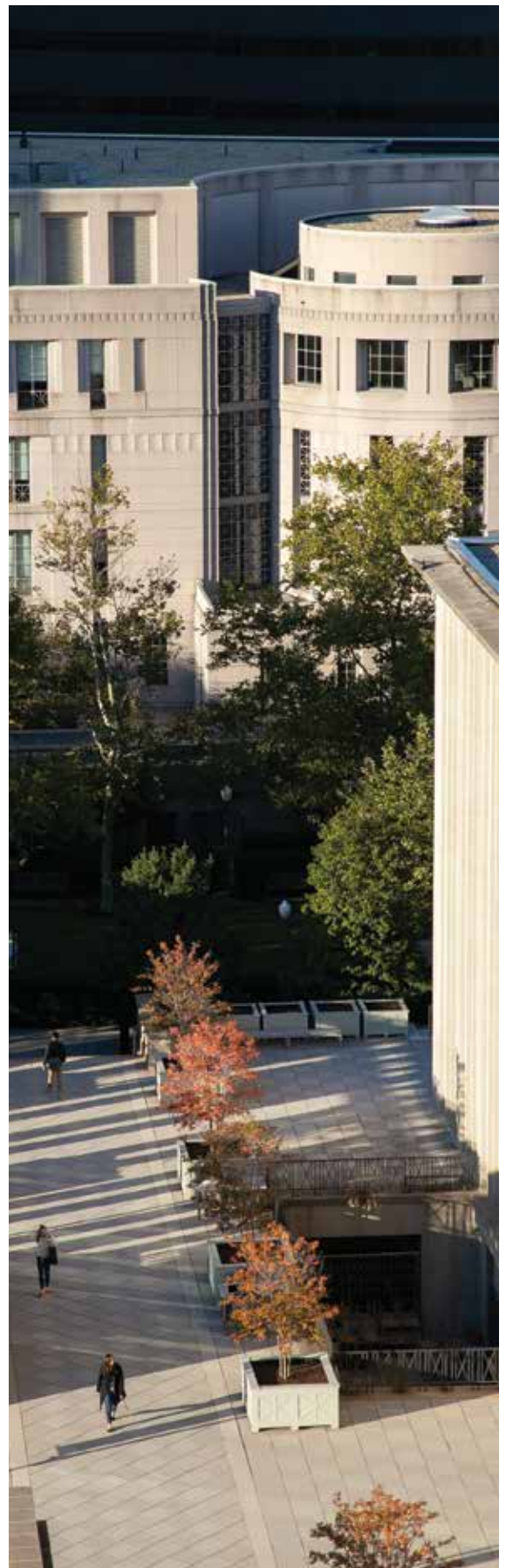
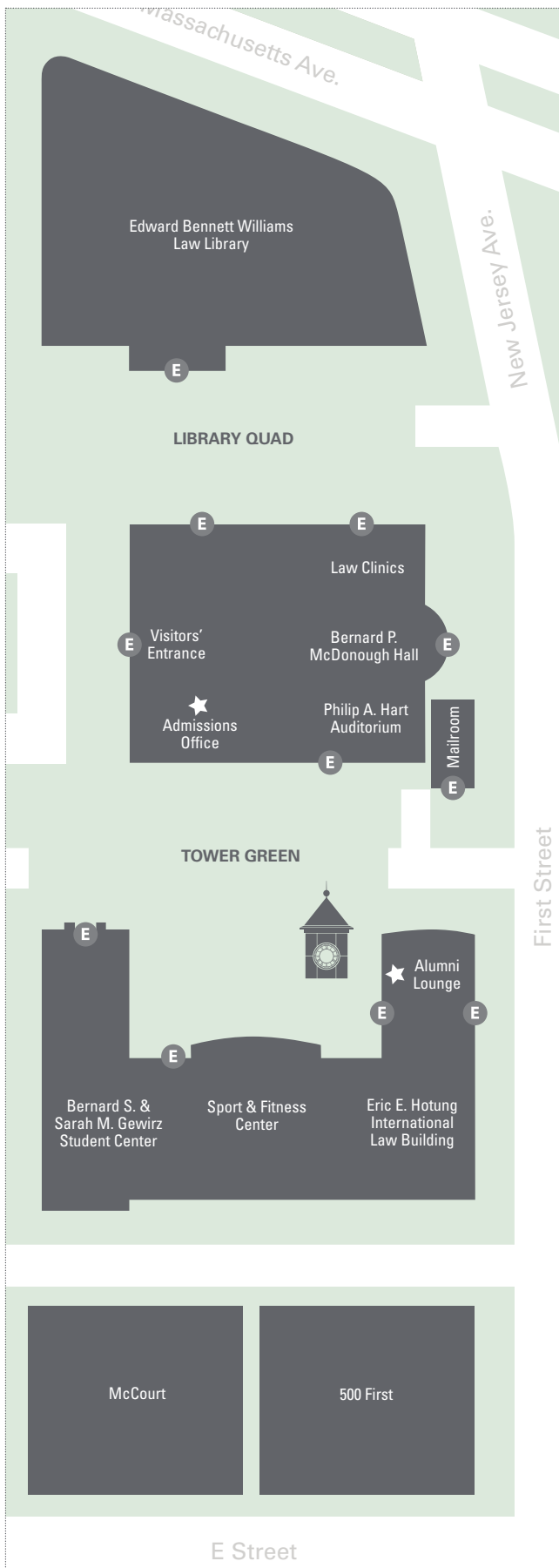
