Except for tuition expenses the budget items below are estimates of reasonable attendance costs and form the basis of financial aid eligibility. If you are over budget in one area re-evaluate your spending to find possible savings and/or reduce your costs elsewhere to compensate. Budgets for Georgetown Law study-abroad, joint-degree, Executive LLM and SJD programs vary and most are less than the full-time budget below. Contact the Office of Financial Aid for more information. Budgets are based on the academic school year (nine (9) months September to May).

The above budgets contemplate shared living arrangements (i.e., sharing housing costs with at least one roommate). When evaluating housing options, the Rent, Utilities & Internet and Local Travel categories should be considered collectively. For example, for leases that include utilities you may effectively combine the Utilities & Internet category with the Rent category. For nearby housing options (those within eight blocks of Georgetown Law), Local Travel must be moved to the Rent category to help subsidize any higher cost of rent in the immediate vicinity.

**Eligibility for Federal Aid requires ½ time enrollment, 6 credit hours for JD and 4 credit hours for LLM/MSL/MLT.**

**Special note for graduating JD Students:** In your final year of attendance your Cost of Attendance will include an additional amount of borrowing eligibility to cover the **cost of the bar exam fees for the DC Bar**. For the 2025-26 academic year, that amount is \$950. These funds generally disburse with your spring semester loan disbursement. If you are planning to sit for the Bar in a different jurisdiction, you may elect to have your Cost of Attendance adjusted to reflect those fees.

\*Some or all instruction for all or part of Academic Year 2025-26 may be delivered virtually. Tuition and mandatory fees have been set regardless of the method of instruction and will not be refunded in the event instruction occurs remotely for any part of the Academic Year.
